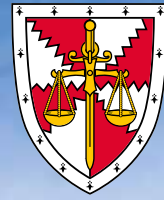

Joint Columbia Law School - Chartered Institute of Arbitrators Course on International Arbitration

**A systematic and comprehensive examination of the law
and practice of international commercial arbitration.**

The course, compressed into a week's time with both lecture and interactive segments, is designed for arbitrators, advocates, in-house counsel and others interested in international arbitration. The course is jointly provided by Columbia University School of Law, through its Center for International Commercial and Investment Arbitration (CICIA), and the Chartered Institute of Arbitrators (CI Arb), through its New York Branch.

The course is a CLE (CPD) course for which NY State CLE credit will be available. Upon completion, all attendees will receive a certificate of attendance from both Columbia Law School and the Chartered Institute.
